On April 22, 2017 at approximately 1:30 AM, Officers Martin and Singh arrived at the Econo Lodge Inn, 730 North Palora Avenue, to conduct a security check due to an increased level of criminal activity in this area.

Officers Martin and Singh saw an adult male subject in the parking lot who was leaning into an open passenger side window of a vehicle. The officers suspected he was burglarizing the vehicle. The officers contacted the suspect who then fled on foot. Officers Martin and Singh chased after him as he ran through the parking lot. The suspect tripped and fell to the ground. Officers Martin and Singh pinned the suspect to the ground and attempted to handcuff him. The suspect resisted the officer's attempts to physically control or handcuff him and held his hands beneath his body. Officers Santanna and Mulcahy arrived and assisted Officers Martin and Singh as they worked to take the suspect into custody. The suspect arched his back and quickly removed his right hand in which he was grasping a handgun. The suspect fired the handgun, shooting Officer Martin in the left leg. Officer Martin grabbed the suspect's right hand as he continued to grasp the handgun and pinned the suspect's hand to the ground, preventing him from firing another shot. The suspect refused to release the handgun and kept his finger on the trigger as the officers ordered him multiple times to remove his finger from the trigger and release the handgun. The suspect posed an imminent danger to anyone in the vicinity. Recognizing this immediate and imminent deadly threat, the officers made the appropriate decision using deadly force in order to prevent serious injury or death to the officers or those in the immediate area.

The suspect was handcuffed and his firearm secured. Officer Mulcahy immediately began providing first aid to Officer Martin as Officers Thornton and Jensen arrived on scene. Officer Mulcahy applied a tourniquet to Officer Martin's left leg and, with the assistance of Officer Thornton, provided care to Officer Martin as fire and medical units were being dispatched. Officer Jensen began securing the scene and initiated a crime scene log. Sgt. Morawcznski arrived, immediately assessed the condition of the officers and suspect and effectively prioritized actions as he assumed command of the scene.
