Summary

Subject: Dedication of Right-of-Way to the State of California [Western Parkway North

of State Route 20]

Recommendation: Adopt a Resolution authorizing the Mayor to execute a grant deed for fee

ownership transferring title to the State of California for a portion of Western

Parkway on the north side of State Route 20

Fiscal Impact: None

Purpose:

To comply with the State's requirements for public access to State Route 20 from Western Parkway.

Background:

In 2013, the City constructed a new intersection at State Route 20 and Western Parkway through a Cooperative Agreement with the California Department of Transportation (Caltrans), dated November 17, 2011.

The Cooperative Agreement with Caltrans required the City to deliver to the State of California legal title to the portion of Western Parkway right-of-way necessary to comply with state and federal requirements. The City approved a grant deed to facilitate this land transfer as to content and form on December 20, 2014 and then submitted it to Caltrans for processing (Attachment 2).

Caltrans has since processed and approved the grant deed, and, in February of this year, requested that the City execute the document to finalize the transfer.

Analysis:

The attached grant deed, including legal description and plat map, was developed in coordination with Caltrans to ensure that access control of the intersection conforms to the provisions outlined in the Caltrans Highway Design Manual.

Fiscal Impact:

None

Alternatives:

There are no viable alternatives.

Recommendation:

Adopt a Resolution authorizing the Mayor to execute a grant deed for fee ownership transferring title to the State of California for a portion of Western Parkway on the north side of State Route 20.


