**Summary**

**Subject:** Purchase of one (1) 6-ton Hot Asphalt Patcher for the Public Works Maintenance Divisions

**Recommendation:** A. Adopt a Resolution authorizing the purchase of one (1) 6-ton hot asphalt patcher vehicle to PB Loader Corporation of Fresno, CA in the amount of \$256,878.69 by piggybacking on Sourcwell Contract No. 052417-PBL, with the finding that it is in the best interest of the City.

B. Authorize the Finance Director to reinstate the budgetary appropriation in the amount of \$220,000 from Account No. 6610-69451, which was approved but not utilized in Fiscal Year 18/19, and to make supplemental appropriations and related transfers in the amounts of \$22,200 from Fund No. 507 (Water), \$3,700 from Fund No. 518 (Wastewater), and \$11,100 from Fund No. 220 (Streets & Roads) unallocated reserves for the additional \$37,000 required for the purchase.

**Fiscal Impact:** \$256,878.69 – Account No. 6610-69415 (Vehicle Replacement Fund)

**Purpose:**

To improve City infrastructure maintenance and operational efficiencies in the Public Works Department.

**Background:**

The Public Works Street Maintenance, Water Distribution, and Wastewater Collection Divisions are responsible for the maintenance of City infrastructure, including repairs and construction utilizing asphalt materials. These duties include pothole repair, pavement patching, service trench restoration, water leak repairs, curb and gutter replacement, overlay projects, and manhole repairs.

Currently, asphalt work requires four pieces of major equipment and a minimum of five Public Works Maintenance Workers to transport and operate the equipment. This method is inefficient compared with today's technology and tools and is no longer the industry standard for asphalt repairs and construction. The industry has evolved to become more efficient and effective with the use of dedicated equipment for asphalt work. A hot asphalt patcher truck, which integrates all

required equipment into a single vehicle, reduces the number of necessary personnel, and has been observed to facilitate higher-quality work by maintaining the asphalt temperature.

In 2018, Public Works maintenance staff evaluated the use of an asphalt patcher and City Council approved the capital acquisition as part of the Fiscal Year 18/19 budget. In November 2018, Council awarded the purchase and staff coordinated the acquisition. During the purchasing process, it was discovered that the awarded vendor did not have the capability to produce the chassis required per the City's specifications, and the purchase was canceled.

### **Analysis:**

In order to move forward with the purchase of the asphalt patcher truck, staff is requesting that the truck meet the following specifications:

- 6 or 8 ton capacity with a heating element to keep asphalt hot and an auger system for dispensing the asphalt
- SS-1 emulsion tank with 50' hose reel and spray nozzle
- Compressor and 90 lb. jackhammer
- Storage area with hydraulic lift for a Vibra-plate
- Spoils bin for disposal of chunks of asphalt
- Fully-insulated top-loading doors

Staff learned that the Sourcewell Cooperative Program, which negotiates cooperative purchasing for local governments nationwide, had conducted a formal bid for a 6-ton hot asphalt patcher matching the City's desired specifications. The contract was awarded to PB Loader Corporation of Fresno, CA. Staff's recommendation is to "piggyback" on Sourcewell's formal bid and price, as is allowed under the City's Purchasing Policies and Procedures, to capitalize on the cost savings of the nationwide contract.

Municipal Maintenance Equipment of Sacramento, CA is the regional vendor that PB Loader Corporation will utilize for coordination, delivery, and warranty support.

### **Fiscal Impact:**

The total cost of the hot asphalt patcher box and truck chassis meeting the City's specifications is \$256,878.69. In order to capture the funds that were originally budgeted for this purchase in the Fiscal Year 18/19 budget, the Finance Director will need to reinstate the budgetary appropriation of \$220,000 that was originally approved. The purchase will also require an additional \$37,000, which staff is recommending be transferred from unallocated reserves from Water (60%), Wastewater (10%), and Streets & Roads (30%).

### **Alternatives:**

1. Direct staff to conduct a formal bid process.
2. Do not authorize the purchase and direct staff to continue the current method of asphalt application.

### **Recommendation:**

- A. Adopt a resolution authorizing the purchase of one (1) 6-ton hot asphalt patcher vehicle to PB Loader Corporation of Fresno, CA in the amount of \$256,878.69 by piggybacking

on Sourcewell Contract No. 052417-PBL, with the finding that it is in the best interest of the City.

- B. Authorize the Finance Director to reinstate the budgetary appropriation in the amount of \$220,000 from Account No. 6610-69451, which was approved but not utilized in Fiscal Year 18/19, and to make supplemental appropriations and related transfers in the amounts of \$22,200 from Fund No. 507 (Water), \$3,700 from Fund No. 518 (Wastewater), and \$11,100 from Fund No. 220 (Streets & Roads) unallocated reserves for the additional \$37,000 required for the purchase.
