# Project Location

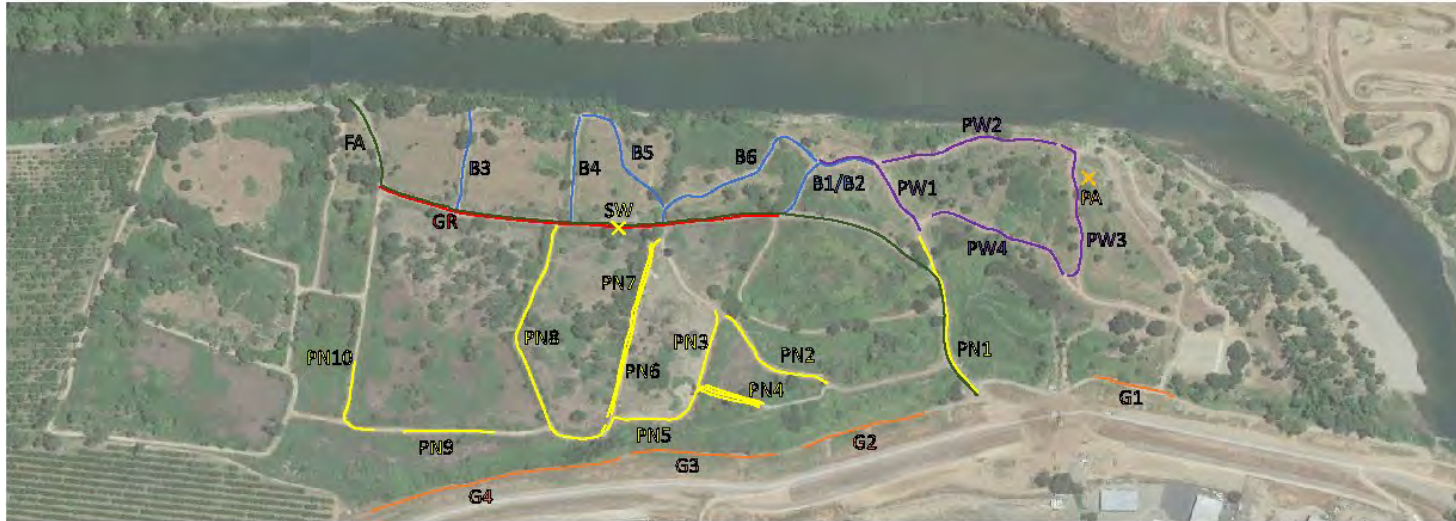




# Background

- 2017 Oroville Dam Spillway Incident caused severe damage to Feather River Parkway.
- City applied and was approved for public assistance from FEMA through CalOES for repairs and reconstruction of damaged facilities .
- FEMA approved repairs to the Feather River Parkway include the following:
  - Water Intake Access Road: Installation of storm-water culverts, fill, compaction, and regrading of eroded surface aggregate.
  - Park: gravel roadways, bike trails, walking trails, trees, picnic areas, concrete pads, and benches.

## FEMA REQUESTED REPAIRS FOR FEATHER RIVER PARKWAY



- G** = Gravel Roadways (4)
- B** = Dirt Bike Trails (6)
- PN** = Pedestrian Trails (10) – Non-Wetland Area
- PW** = Pedestrian Trails (4) – Wetland Area
- PA** = Picnic Area
- FA** = Water Intake Facility Access Road
- GR** = Gravel Roadways, Section 2
- SW** = Storm Water Conveyance Culverts



## Background, cont.

- On August 22, 2019, staff provided an RFP to local builder/contractor exchanges.
- On September 17, 2019, Domenichelli and Associates, Inc. submitted the only proposal for FEMA repairs for an amount of \$119,176.
- Proposal includes EN2 Resources, Inc. as a subcontractor to complete environmental permitting.
- Both firms have direct experience and knowledge of the Feather River Parkway Phase I & II Projects.



# Fiscal Impact

- \$789,567 – Project Estimate provided in FEMA Grant Report
  - FEMA will reimburse 75%, CalOES will reimburse 18.75%, leaving City responsible for 6.25% of costs.
- Staff recommends a supplemental appropriation from unallocated CIP General Fund and Water Funds.
  - \$150,000.00 – Account No. TBD (FEMA FRP Repair)
    - \$140,62.004 – Federal & State Grants – 93.75%
    - **\$7,313.00 – City Match (General Fund) – 4.875%**
    - **\$2,063.00 – City Match (Water Fund) – 1.375%**
- Staff will return to council with future funding and recommendations on how to proceed as repair project progresses.

# Recommendation



- A. Adopt a Resolution awarding a Professional Services Agreement to Domenichelli and Associates, Inc. of El Dorado Hills, CA in the amount of \$119,176 for design, project management, and environmental mitigation services for the 2017 Storm Damage Repair Project, with the finding that it is in the best interest of the City, and authorizing the City Manager to execute any necessary documents, upon approval by the City Attorney as to legal form.
- B. Authorize the Finance Director to perform a supplemental appropriation and related transfers of \$7,313 from unallocated General CIP Funds and \$2,063 from unallocated Water Funds to Account No. 1273 (FEMA Feather River Parkway Repair).
