Approve a low-mod funding commitment of \$1,000,000 contingent on the successful project approval from the state Affordable Housing and Sustainable Communities program, for a proposed multiphase 176-unit affordable housing complex and authorize the City Manager to execute any associated documentation related to the commitment of the funding
- B. Funding commitment time duration to coincide with the planning entitlement schedule (not to exceed 2 years). Any extensions of the funding duration are to be null and void without reconsideration by Council
- C. Adopt **Resolution 21-050** to execute a Cooperation Agreement between The City of Yuba City, the Regional Housing Authority, and Sutter Community Affordable Housing to Comply with the Requirements of grant application under the Affordable Housing and Sustainable Communities Funding Program for Richland Village Affordable Housing

16. Shopping Carts Ordinance Update

Kevin Cotter submitted comments via email

Vice Mayor Shaw moved and Councilmember Espindola seconded the motion to:

- A. Open a public hearing, and after consideration;
- B. Introduce Amending Chapter 22 to Title 5 of The Yuba City Municipal Code Regulating Shopping Carts, and waive the first reading. The motion amended draft ordinance Section 5-22.130 to retain the original language for penalties and \$50 dollar charge amount in the existing Section 5-22.110, as revised, and as previously noted. (See below.)

The motion was passed with a 4-1 vote (Mayor Boomgaarden opposed)

Ordinance language updated at first reading:

Section 5-22.130: Penalties

- (a) Any person who violates any provision of this chapter may be subject to the following penalties:
 - Any person who violates Section 5-22.040 of this chapter shall be guilty of an infraction. Any person who violates Section 5-22.040 of this chapter more than two times within a six-month period shall be guilty of a misdemeanor;
 - (ii) Subject to the administrative penalties and citation process set forth in Title 1, Chapter 6 of this Code; and
 - (iii) Subject to a civil penalty of \$50.00 for every business day of noncompliance in excess of three during a six-month period.
- (b) Any business who violates any provision of this chapter may be subject to the following penalties:
 - (i) The administrative penalties and citation process set forth in Title 1, Chapter 6 of the Yuba City Municipal Code; and
 - (ii) A civil penalty of \$50.00 for every business day of non-compliance.
- (c) The remedies and penalties provided herein are cumulative, alternative and nonexclusive. The use of one does not prevent the use of any other criminal, civil, or administrative remedy or penalty authorized by, or set forth within the Yuba City Municipal Code. None of the penalties or remedies authorized by, or set forth within the Yuba City Municipal Code shall prevent the City from using another penalty or remedy under local ordinance and/or State statute which may be available to enforce this chapter or to abate a public nuisance.
