Summary

Subject: Updated Appointments to City Council Regional Boards and Committees
Recommendation: Approve the Mayor's Assignments to Regional Boards and Committees for FY 2016-17
Fiscal Impact: None.

Background:

Yuba Sutter Mosquito Vector Control District: Upon the end of his term as Councilman, Former Councilmember John Dukes requested to continue his term as the City's member of the Sutter Yuba Mosquito Vector Control Board of Trustees, which expires on December 31, 2018. On August 31, 2017, the City received notice that Mr. Dukes submitted his resignation due to relocation and another appointment needs to be made to complete his term. This Board pays \$100 a meeting stipend to Trustees.

Yuba Sutter Arts: The City has not made an official appointment to the Yuba Sutter Arts Board of Trustees since March 2014, when our appointed member resigned. Since that time, Yuba Sutter Arts has reorganized and Councilmember Harris is currently serving as a private citizen on the Board of Trustees.

Recommendation:

Appoint Mayor Stan Cleveland to the Yuba Sutter Mosquito Vector Control District to complete the term of John Dukes, which expires on December 31, 2018.

Appoint Councilmember Shon Harris to be the City's official representative on the Yuba Sutter Arts Board of Trustees.
