**Fiscal Impact**: \$803,747: Funds to be drawn from various accounts in both the Wastewater

and Water Treatment funds as well as Community Services swimming pool

5130-63701 account. The actual cost may vary based on usage.

#### **Purpose:**

To provide chemicals to the Water and Wastewater Treatment plants and swimming pool, at the best prices available.

#### Background:

The contracts are necessary to provide chemicals to be used in the purification of water for human consumption, in the treatment of wastewater, and in the swimming pool water.

### **Analysis:**

Two years ago, the Water and Wastewater Departments joined a consortium for the purchase of chemicals. The Bay Area Chemical Consortium (BACC) is a group of sixty-six (66) municipalities and water agencies that have been working together for several years to consolidate all chemical purchases into one formal bid to receive the best possible prices for all agencies. Dublin San Ramon Services District put the bid specification together with all other agencies reviewing their own chemical specifications to assure that all items included in the bid were correct. The formal bid specifications were sent out to multiple vendors for each type of chemical for a total of approximately 50 different vendors.

The BACC does not bid all chemicals that the City uses thus having to conduct our own bid process for two (2) chemicals.

No bids were received for Category-Lime Slurry. The City bid this product last fiscal year with the possibility of a one year extension. To keep all the chemicals on the same purchasing cycle we choose not to offer the extension. When no bids were received we offered the extension to the vendor and they accepted. The price is in line with the price from last year.

#### Fiscal Impact:

\$803,747 Funding for these purchases is budgeted in the Water and Wastewater fund portions of the budget as well as a Community Services account. The account numbers to be used for these purchases are as follows:
